HEALTH & SAFETY UPDATE

Preparedness and Response: Coronavirus (COVID-19)

AzLTA joins industry, government and national allies in closely monitoring the Coronavirus (COVID-19). We want to make you aware of a new resource from U.S. Travel based on routine contact with authorities at the White House, Health and Human Services, Centers for Disease Control and Prevention, the Department of Homeland Security and officials at several U.S. airports. <u>U.S. Travel has created an online tool-kit</u> with data, information and updates about ongoing developments and how our industry can be constructive partners to current efforts.

ADVOCACY

AzLTA, along with our Government Affairs firm Molera Alvarez and the seasoned expert guidance of Jaime Molera, are tracking dozens of bills during this fast-moving session. <u>Visit our website</u> for the latest information. Here are highlights of recent actions for priority bill S.B. 1335:

• SB1335 Tourism Marketing Authority Legislation: Passed Senate Finance Committee on Wednesday, February 19 following a presentation by the bill's sponsor Sen. Tyler Pace, AzLTA Chairman and Visit Tucson President & CEO Brent DeRaad and lead lobbyist Barry Aarons of the Aarons Company. The State's two largest Chambers (Arizona Chamber and the Greater Phoenix Chamber) join a growing list of supporters for the Tourism Marketing Authorities (TMA) enabling legislation. SAFE Action Project

SAFE Action Project (Safeguarding All From Exploitation) is a collaboration between the Attorney General's Office, Homeland Security and Arizona Anti Trafficking Network. This is a training certification program specifically designed for the travel and hospitality industry at no cost. In January the AzLTA team became SAFE Certified.

legislative wins achieved during the past year's challenging political environment, including Brand USA's seven-year reauthorization and the enactment of the United States-Mexico-Canada Agreement. Arizona Cactus League Spring Training

15 teams, the Phoenix metropolitan area holds
claim to the greatest concentration of professional
baseball facilities found anywhere in the United
States. These games provide a forum to share
operational efficiencies, to establish and nurture
business relationships with respective Major



League Baseball franchises and to facilitate and participate in activities to promote and fundraise for the Cactus League. The Cactus League industry continues to grow and contributes an estimated \$644 million annually in economic impact in the state of Arizona.

Waste Management Phoenix Open

January brought many of the world's top PGA Tour professionals to gather at the Tournament Players Club of Scottsdale for the Waste Management Phoenix Open. The field of 132 players competed for a \$7.3 million purse, a \$1.314 million check for first place and 500 FedExCup points. The week-long event delivers an annual \$277 million economic impact. After making his second birdie on the 18th hole in less than a half hour, Webb Simpson won the Waste Management Phoenix Open in a playoff over Tony Finau.



NCAA Women's Final Four

Congratulations to Visit Phoenix and the City of Phoenix for being named as a finalist to host the Women's Final Four in 2025 and 2026. The NCAA DI Women's Basketball Committee named Columbus (Ohio), Phoenix, Portland (Oregon) and Tampa as finalists. Each city must submit final bids by April 13, before site visits from June through August, and final presentations in September. The two chosen sites will be announced in October.



Tucson Gem, Mineral & Fossil Showcase

The start of February delivered two great weeks of the annual Tucson Gem, Mineral & Fossil Showcase which takes place at multiple locations across the city. Most of the shows are open to the public, except for certain trade shows which require registration with a business license. It is the single highest revenue-producing event for the Tucson economy, generating an estimated economic impact of \$120 million.
