FEDERAL UPDATE



U.S. TRAVEL EU REMOVES USA FROM THE LIST OF **COUNTRIES FOR WHICH TRAVEL** RESTRICTIONS SHOULD BE LIFTED

This week, the European Union (E.U.) removed the United States from its list of countries for which travel restrictions should be lifted. U.S. Travel's Executive Vice President of Public Affairs and Policy Tori Emerson Barnes issued the following press statement, which received media pickup in both the **U.S.** and **Europe**:

"This is a disappointing development following the boost in inbound visitation by vaccinated travelers that many E.U. countries experienced this summer. It's a setback despite the uptake in vaccinations—the tool that's highly effective against the variants—which are on the rise on both sides of the Atlantic.

U.S. TRAVEL LABOR DAY WEEKEND: TRAVEL AT A

As Americans look to fit in one final summer getaway, analysts <u>predict</u> that 43 million Americans will hit the road for Labor Day—only a 10% decrease from 2019. And as summer comes to a close, the percentage of American travelers with travel plans over the next six months remains strong at 88%.

However, U.S. Travel's latest monthly travel data report shows that as concerns over the Delta variant mount and new COVID-19 cases surge, there is a growing risk of eroding the positive travel sentiment. Approximately 35% of American travelers have reported a negative impact to their travel plans. This uncertainty is especially felt with regard to international bookings, which remain stalled.
